

# DOCTORAL SCHOOLS CALL FOR COURSES – ACADEMIC YEAR 2020-2021

The Doctoral Schools call on professors and postdoctoral fellows to submit proposals for the organisation of front line activities that directly address current training needs and demands of young researchers.

The Doctoral Schools will financially support specialist courses organised in 2020 and 2021.

**Specialist courses** are especially designed for PhD researchers wanting to deepen their discipline-specific knowledge. Therefore, these courses must comply with the following criteria:

- Taught interactively by one or more (international) specialists in the field
- Organised by Ghent University professors or postdoctoral researchers
- Relevant to PhD research conducted at Ghent University
- Minimum 15 contact hours

**Note:** as a part of the measures taken to help slow the spread of COVID-19, course organizers should opt for blended/online alternatives whenever possible. On-campus formats require explicit approval from the relevant Doctoral Schools Councils, and are reserved for courses which cannot reasonably take place in an online format (e.g. courses with specific infrastructure requirements such as a laboratory setting). As a result of this change, the Doctoral Schools will show flexibility in the contact hour requirements. The prescribed minimum contact hours (15 hrs) do not need to be turned into a corresponding amount of synchronous digital instruction: flipped classroom concepts with a few hours of synchronous digital instruction supplemented by e.g. assigned reading, online asynchronous discussion etc. are acceptable and in most cases likely preferable. In general, we ask that course organizers attempt to put together a workload that, taken together, at least approximates the regular minimum contact hours.

Priority will be given to proposals put forward by inter-university partnerships including (at least) two other
 Flemish universities

Organisers who wish to organise a transferable skills seminar are requested to contact the Doctoral Schools Office (doctoralschools@ugent.be).

Beneficiaries need to acknowledge the relevant funding bodies in all communications about the course (i.e. flyers, website, etc.)

**Impact of COVID-19 measures:** as a rule, courses should be pitched as online where possible. Any applications for face-to-face courses require clear and explicit motivation for why they need to take place in person.

**Abstract (max. 5 lines):** Little topics are studied in so many disciplines (both in general and at UGent) as topics on work and the labour market. Therefore, to thoroughly answer research questions related to these topics, it is necessary to surpass a merely monodisciplinary approach. In this specialist course, participants from multiple disciplines will (i) be immersed by means of seminars in multi- and interdisciplinary research tools to study work and the labour market and (ii) draw up an original research proposal in collaboration with another participant from another discipline.

Topic of the course (max. 10 lines): In the first part of this specialist course, participants follow eight online seminars by eight different lecturers from different disciplines and different backgrounds (i.e. both academic and non-academic). The focus of these eight seminars will be on the tools that are used to conduct studies on topics related to work and the labour market. Six of these seminars will cover multi- and interdisciplinary research methods used at UGent. Potential topics covered in these six seminars are burn-out; work and digitalisation; labour market discrimination; overeducation; aging; wellbeing at work (non-exhaustive list). Additionally, two other seminars will cover the use of (governmental) datasets. These in total eight seminars should provide students with the necessary methodological tools to draw up an original



research proposal on one of the abovementioned topics in the second part of this specialist course. To ensure participants draw up a multi- or interdisciplinary research proposal, this proposal is drawn up in collaboration with another participant from another discipline (and preferably from another Doctoral Schools).

**Objectives of the course (learning outcomes) (max. 15 lines):** Six distinct goals are identified for this specialist course. **Goal A.** The participants are introduced to accessible, state-of-the art, multi- and interdisciplinary UGent research on topics related to work and the labour market. **Goal B.** The participants are introduced to methods (data collection and data analyses) from multiple disciplines which may not be common in their own discipline but which may be considered innovative when applied in that discipline. **Goal C.** The participants are introduced to two datasets which may allow them to answer innovative research questions in their own discipline. **Goal D.** The participants' point of view with respect to meaningful research questions and the participants' knowledge of relevant theories on topics related to work and the labour market are broadened. **Goal E.** The participants are stimulated to enter into multi- or interdisciplinary collaborations with researchers from other disciplines. **Goal F.** The participants' critical research attitude is strengthened.

Relevance of the course to the PhD research conducted at Ghent University (max. 10 lines): Research on topics related to work and the labour market is conducted at at least nine departments from six faculties at UGent. This specialist course immerses participants in the tools that are used across these disciplines to conduct research on topics related to work and the labour market (Goal A above). This may lead to innovative research by the participants both on a methodological level (Goal B and Goal C above) as on the level of meaningful research questions explored (Goal D above). Additionally, it stimulated the participants to enter into multi- or interdisciplinary collaborations (Goal E above) which is more and more encouraged by UGent, marked by the introduction of six new interdisciplinary research consortiums (IDCs), among which the IDC 'UGent @ Work' which will be the main organising entity of this proposed specialist course. Finally, it strengthens participants' critical research attitude (Goal F).

Added value/complementarity to existing courses (max. 10 lines): This course distinguishes itself from other, existing specialist courses by its explicit multi- and interdisciplinary approach. This is apparent from the concept that (i) eight different lecturers from different disciplines and different backgrounds (i.e. both academic and non-academic) will present their research methods and datasets which can be used to study topics related to work and the labour market and (ii) participants are stimulated to enter into a concrete, original, multi- or interdisciplinary research collaboration with another participant from another discipline. In addition, it combines aspects of on the one hand specialist courses that focus on the transfer of field-specific knowledge and theories and on the other hand specialist courses that focus on methodological training.

Teaching methods (e.g. lectures ex-cathedra, (poster) presentations by doctoral researchers, discussion, practical exercises, homework before or during the course) and number of hours per type of activity: The activities of this specialist course are concentrated in one single week. This way, the participants are intensively immersed in the UGent research on topics related to work and the labour market.

The first part of the course consists of eight online seminars. In these eight seminars, eight different lecturers from different disciplines and different backgrounds (i.e. both academic and non-academic) present research methods and datasets which can be used to study topics related to work and the labour market. After each one of these seminars, the participants are expected to hand in a one page summary.

The second part of the course consists of drawing up a research proposal inspired by the research tools covered in the eight seminars. This research proposal is drawn up in collaboration with another participant from another discipline.

**Evaluation criteria (e.g. 100% attendance, active participation, presentation, writing a paper)**: Eight syntheses of one page of the eight seminars (30%) and presentation and defence of own research proposal (70%).



**Teaching material that will be available to the participants:** Introductory slide show; slide shows of the eight seminars; research papers and datasets discussed during the seminars (voluntary reading and inspiration for own research proposal).

Stijn is involved in several courses on (labour) economics and research methods at Ghent University and University of Antwerp. In the past he organised the specialist course 'Research Seminars in the Social Study of Migration and Refugees'. His research is mainly situated in the broad field of labour economics. Since 1 September 2020, Stijn is the main supervisor of the interdisciplinary consortium (IDC) 'UGent @ Work'.
